MINUTES OF THE MEETING OF THE BOARD OF TRUSTEES WEDNESDAY, DECEMBER 16, 2020

A meeting of the Board of Trustees of the Incorporated Village of Head-of-the-Harbor was held on Wednesday, December 16, 2020 at 7 PM via Zoom. Those present were the following members Mayor Douglas A. Dahlgard, Deputy Mayor Daniel W. White, Trustees L. Gordon Van Vechten, Judith C. Ogden and Trustee Jeffrey D. Fischer. Also in attendance Village Administrator/Clerk, Margaret O'Keefe; Village Treasurer, Patricia Mulderig; Co-Counsel, Philip Butler; Police Chief, Charles M. Lohmann and Building Inspector, Robert O'Shea. Late arrival at 7:10 PM- Village Attorney, Anthony S. Guardino. Also in attendance, village residents: Collette Porciello, Meg Shutka and Kathleen Diana.

Pledge of Allegiance.

Mayor Dahlgard reconvened the public hearing on Local Law (Intro) #6 of 2020, "AMENDING CHAPTER §165 OF THE CODE OF THE VILLAGE OF HEAD OF THE HARBOR TO REGULATE PORTABLE STORAGE UNITS AND TEMPORARY BULK WASTE CONTAINERS". Discussion ensued. The current draft is to be amended to include a delayed effective date of 90 days from the date of adoption. Mayor Dahlgard declared the hearing held open until the Trustees meeting scheduled to be held on January 20th, 2021 at 7 PM.

Anthony Guardino logged into the remote meeting at 7:10 PM.

Mayor Dahlgard convened the public hearing on Local Law (Intro)#7 OF 2020, "A LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW §3-c". Discussion ensued. Upon the conclusion of comments from the Board and the public, Mayor Dahlgard closed public hearing.

Mayor Dahlgard convened the public hearing on the village's 2021/2022 budget. Copies are on the village website and at Village Hall. Discussion ensued. Upon the conclusion of comments from the Board and the public, Mayor Dahlgard closed public hearing.

A public hearing was concluded on the 16th day of December 2020, at 7:00 PM, at the Village Hall, 500 North Country Road, Head-of-the-Harbor, New York, to consider the adoption of a local law as Local Law (Intro)#7 of 2020, "A LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW §3-c".

It was upon motion by Trustee Van Vechten, second by Trustee Fischer and voted upon as follows:

Be it enacted by the Board of Trustees of the Incorporated Village of Head of the Harbor as follows:

Section 1. Legislative Intent

It is the intent of this local law to allow the Village of Head of the Harbor to adopt a budget for the fiscal year commencing March 1, 2021 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

Section 3. Tax Levy Limit Override

The Board of Trustees of the Village of Head of the Harbor is hereby authorized to adopt a budget for the fiscal year commencing March 1, 2021 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c. Section 4. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective Date

This local law shall take effect immediately upon filing with the Secretary of State.

A public hearing was concluded on December 16, 2020 at 7 PM on the village's 2021/2022 budget. It

WHEREAS, the Village of Head of the Harbor, with the assistance from the Town of Smithtown, has gathered information and prepared the Suffolk County Multi-Jurisdictional Multi-Hazard Mitigation Plan; and

WHEREAS, the Suffolk County Multi-Jurisdictional Multi-Hazard Mitigation Plan has been prepared in accordance with the Disaster Mitigation Act of 2000; and

WHEREAS, the Village of Head of the Harbor is a local unit of government that has afforded the citizens an opportunity to comment and provide input in the Plan and the actions in the Plan; and WHEREAS, the Village of Head of the Harbor have reviewed the Plan and affirms that the Plan will be updated no less than every five years, and

NOW THEREFORE, BE IT RESOLVED, by the Board of Trustees that The Village of Head of the Harbor adopts the Suffolk County Multi-Jurisdictional Multi-Hazard Mitigation Plan as this jurisdiction's Natural Hazard mitigation Plan and resolved to execute the actions in the Plan.
